Sub: Transfer of Players

Most of the States / Clubs seek transfer of player from one State to another State for a particular event / Championship. After the conclusion of the event / Championship, the player, who seek transfer returns back to their parent State. Henceforth, this type of transfer will not be permitted even though the original State has given "No Objection Certificate" to play for another State.

If Federation found such type of Transfer, the Team, which is utilizing the services of player, will be penalized suitably.

However, regular Transfer of Players, who seeks transfer from one State to another State shall submit their application to the Federation along with a Transfer Fee of Rs.1,000/- with a copy of "No Objection Certificate" obtained from the State Association where the player concerned seeking transfer do belong during the time of Transfer. The Federation will record the transfer and issue Transfer Certificate / NOC to the party's concerned.

The Players can participate from his employer's State or home State during the Calendar year of the VFI i.e April to March. Other than this no transfer will be allowed to any player or players.



All States / Units affiliated to Volleyball Federation of India

Sub: PLAYERS AGREEMENT

Registered Player of our Federation (Men & Women), who desires to play for Foreign Clubs in abroad should follow strictly, the following terms and conditions.

- 1) The letter of confirmation received by the players from the foreign club with address, contact number and E-Mail ID should be sent to the Federation.
- 2) Player, who is working in the Department, he/she should get "No Objection Certificate" and submit the same to the Federation.
- 3) The Federation after careful examination shall issue "No Objection Certificate" to the player concerned and the player must remit a sum of US \$ 1,500 to the Federation with a request that the player should return to our country for International events as and when required.
- 4) If any Player gives adverse remarks about the Federation to the Print and Electronic Media / Doordarshan without the permission of Volleyball Federation of India, they are liable for disciplinary action with immediate effect.

If the players fulfill the above condition he/she can be allowed to play in abroad.
