<u>Sub</u>: <u>43<sup>rd</sup> Junior National Volleyball Championship for Boys & Girls – Paravoor, Ernakulam, Karala – 19-25 April 2017</u>

Kindly refer to our Circular dated 20<sup>th</sup> December 2016 on the subject Championship. We are pleased to confirm that the 43<sup>rd</sup> Junior National Volleyball Championship for Boys and Girls will be held at **Paravoor, Ernakulam, Kerala from 19<sup>th</sup> to 25<sup>th</sup> April 2017**.

We are also pleased to inform that today (10.01.2017) the applications filed by the VFI in the appeals bearing no. CMA No. 2823 to 2825 of 2016 were listed before the Hon'ble High Court Madras. The Hon'ble Court had passed an order specifically recording the statement of VFI that the 43<sup>rd</sup> Junior National Championship of VFI will be held in April 2017 only. The Learned Judge has also recorded the statement of the advocate for Shri Avadesh Kumar that the tournament proposed in Karnataka between 13<sup>th</sup> to 19<sup>th</sup> January 2017 is not being conducted by Chaudhary Avadesh Kumar but is being conducted only by the Karnataka State Volleyball Association. VFI is not associated with this tournament proposed in Karnataka. The Hon'ble Court has held that the validity of this Tournament would be decided in the Appeals which are *sub judice* and will be heard on 19<sup>th</sup> January 2017 by the Hon'ble High Court, Madras.
