It has come to the notice of the Volleyball Federation of India that Shri Avadesh Kumar is spreading false information among Members that he is the President of VFI and that he had attended the Executive Committee Meeting of IOA on 9th November 2017 in capacity of President VFI. All members are requested to make note of the following: -

- (i) Shri Avadesh Kumar has circulated pictures of himself attending the meeting dtd 09/11/2017 of the Executive Committee of the IOA and is misleading the general public into believing that he attended the meeting as President, VFI. This is totally incorrect, false and mischievous.
- (ii) Shri Avadesh Kumar has not attended the IOA Executive Committee Meeting on 09/11/2017 in capacity of President, VFI.
- (iii) The IOA also is fully aware and has recognized that Shri Avadesh Kumar is not the President of the VFI. In this regard kindly note IOA's letter dated 24/05/2017 (**Annexure 1**)
- (iv) Shri Avadesh Kumar has attended the meeting held on 09/11/2017 only in capacity of being the elected member of the Executive Committee of the IOA. You must also kindly make note that the term of the present Executive Committee of the IOA also has come to an end. The elections for the new Executive Committee of the IOA have been announced for 14th December 2017.

Hence, we request all members not to be misled by this false and mischievous propaganda of Shri Avadesh Kumar. All members are requested to ensure sufficient publication of this circular and dissemination of this clarification in the interests of the players and general public.
