APPLICATION FOR THE ATHLETE'S COMMISSION

Notice calling for applications for selection of 4 (four) 'Sportspersons of merit' 1 Men & 1 Women in Volleyball and 1 Men & 1 Women in Beach Volleyball to be part of the Executive Committee of the Volleyball Federation of India.

Pursuant to order dated 09.05.2025 in WP (C) 2136/2024 Passed by Hon'ble High Court of Delhi, which are reproduced as under:-

- (vi) **Within a period of four weeks from the election of the new elected body, an Interim Athletes Commission shall be established as per the existing Statutes of FIVB.** The Athletes Commission shall elect 4 persons, who shall be athlete representatives in the Executive Committee, for ensuring representation of 25% of sports persons in the Executive Committee of Volleyball Federation of India.

Mr. Ramanand Choudhary, Secretary General, Volleyball Federation of India (VFI) was tasked to amending the constitution of the Volleyball Federation of India (VFI) and formation of an interim Athlete's Commission as per the FIVB Statues. Now, in terms of the amended regulations of the Athlete's Commission of the Volleyball Federation of India shall comprise of **8 (eight) (2 Men & 2 Women in Volleyball and 2 Men & 2 Women in Beach Volleyball)** "Sportspersons of Merit". The selection of the "Sportsperson's of Merit" would be done by the voters of Athlete's Commission of VFI, as per eligibility criteria set out in the notice calling for applications for "Sportsperson's of Merit" published on VFI website.

The **4 selected (1 Men & 1 Women in Volleyball and 1 Men & 1 Women in Beach Volleyball)** "Sportsperson's of merit" shall be voting members of the VFI 's Executive Committee. In the interest of time, The Secretary General, VFI, has issued a notice calling for applications from affiliated State Volleyball Association's / UT's, can send **1 Men & 1 Women in Volleyball and 1 Men & 1 Women in Beach Volleyball** interested persons meeting the eligibility criteria set out in the amended Athlete's Commission of VFI and in the application form for Sportsperson's which is duly uploaded on the VFI website. **The last date of application is 5 p.m on 12th July, 2025.** Applications have to be submitted at - **vfi2005@gmail.com through** affiliated State Volleyball Association / UT's. The Notification of the election of Athlete's Commission will be issued by the **Returning Office on 12th July, 2025.**

Note: The selection process is subject to the VFI 's amended Athlete's Commission regulations being approved at VFI's Emergent Executive Committee Meeting held at New Delhi on 30.06.2025.
